Reconnection Charge: For restoration of service for discontinuance pursuant to Section 17-1-9, the Utility is authorized to charge a service fee.

All past due amounts are subject to late fees and delinquent charges per Ordinance 17-1-5 C. Rendering and Payment of Bills: All customers shall be given at least twenty-one calendar days from the date of rendition of a bill for payment in full before the bill is deemed delinquent. On the date the bill is deemed delinquent (due date for balance) a late fee of 10% of the amount owed will be assessed, as well as a delinquent charge of 1.5% per month. The delinquent charge of 1.5% on the total amount owed will begin to accrue daily on the date the balance is deemed delinquent.
